- **a.** Fences Because of recent storms, the order of repair of the PID6 fences is changed to the allow storm damage to be the priority followed by Parkwood Hills, Tarrant Parkway, and Beach. Storm damage totaled \$8,853. Insurance will pay all but our \$1,000 deductible. Fences that are leaning, but not from storm damage, are being inspected to determine cause and will be fixed ubder warrantee.
- b. Landscaping Fescue seeding test was determined to be successful. The areas at Arcadia Park 1, Basswood Blvd, and Redwood Trail will be reseeded soon.
- c. Prairie Grass Area Cecilia Shilling moved that the Prairie Grass Area in Arcadia Park 3 be registered as an official Registered Prairie. It will be moved annually in late January to early February and reseaded as necessary. James Harrison seconded the motion. The motion carried.
- d. Capital Improvements Robin is researching equipment and locations for exercise stations along walking paths. Initial extimates are \$25,000 for equipment and \$25,000 for installation.
- e. 2017-2018 Budget Cecilia Shilling moved that the Spring color change be reinstated. Al Cloud seconded the motion. The motion carried.

- d. Wild Flower Areas Robin is researching potential areas and costs of adding wildflower areas within the PID6 parks.

- f. PID Administrator Robin stated that Kip Dernovich said a new PID Administrator with the City has been hired. She will begin transiting into the new role within the next month or so.
